The 2014 George Mason District Camporee will be a cooperative event with the Fairfax County Fire and Rescue Academy and volunteers from the Fairfax County Community Emergency Response Team (CERT) program, which prepares regular citizens to safely help themselves, their families, and their communities during major emergencies where first responders are delayed.

The scenario for this Camporee is a mass evacuation of troops from George Mason District as Hurricane George tracks into the center of Fairfax County. County Government has requested that as many scouts as possible evacuate to the Fire and Rescue Academy on West Ox Road. Scouts (and adults) must travel light. Each person should bring a small “Go Bag” and sleeping bag with pad (see “evacuee gear list”). No camping items (e.g. tents, stoves) required.

The program begins early morning Saturday, 11 October, and ends Sunday morning. Directed by CERT volunteers, scout patrols will conduct a variety of rescue and self-recovery activities designed to give the volunteers experience in managing volunteers, challenge the scouts in an austere environment, and generally be a good time for all.

The cost of the event is \$25 per person, which includes a custom event patch for each participant, streamers for patrol flags, three meals (Saturday lunch, Saturday dinner, and Sunday breakfast), and all other event costs.

The nature of the event is not suitable for Webelos Scouts per the terms of The BSA Guide to Safe Scouting.
