


# Troop 349 Shoot Sports Campout

The Troop 349 shooting sports campout will be from 20-22 November. Camping will be at the Sky Meadows State Park. Shooting will be at the Clark Brothers Shooting Range which is 37 minutes away. Scouts and adults will caravan to the range in two groups on the 21st. The first group will proceed to the range to shoot. The second group will remain at Sky Meadows and complete the Pioneering Merit Badge. At mid-day, the two groups will switch.

Scouts and adults (with pre-arranged exceptions) should leave all personal firearms and shooting gear at home. .22 bolt-action rifles, ammunition, hearing and eye protection will be provided.

The cost is \$75 per participant (covers food, lodging, mileage, camping area, ammunition, and personal protective gear), \$50 for adults

### **Sky Meadows General Information**

Sky Meadows State Park is located at 11012 Edmonds Ln, Delaplane, VA 20144. We have reserved the Washington Loop Campsite. Rich in history, this 1,864-acre park has scenic views, woodlands and the rolling pastures of a historic farm that captures the colonial through post-Civil War life of Mount Bleak House. Nature and history programs are offered year-round. Hiking, picnicking, fishing and primitive hike-in camping for families and groups are favorite activities in this peaceful getaway on the eastern side of the Blue Ridge Mountains. The park has 10.5 miles of bridle trails, 24 miles of hiking trails, 9 miles of bike trails and Appalachian Trail access.

### **Shooting Information**

Clark Brothers' is a private range provided for the customers of Clark Brothers Gunshop, 10016 James Madison Hwy, Warrenton, VA 20186. Clark Brothers will be providing our ammunition and personal protective gear. The Assistant Scoutmasters will be providing .22 bolt action rifles to use on the range.

Scouts will be expected to be on best behavior at the range. We will receive a range safety briefing in addition to the ones the Scouts have received from the troop. In order to ensure the safety of all involved, Scouts must follow all rules and directions to the letter.

All Scouts and adults must have the two sets of liability forms completed (one for BSA, and one for Clark Brothers). Scouts also must have a completed range card. Blank cards and forms will be provided with this packet.

The undersigned, being above the age of 18 years (and the legal guardian of the Minor named above, if any), on behalf of myself and the Minor, in consideration of the revocable license granted to enter and use the "shooting range" operated by Clark's Gun Shop, Inc. T/A Clark Brothers (the "Company") do consent and agree to the terms, conditions and provisions contained in this Revocable License to Use Shooting Range and Release and Hold Harmless Agreement (the "Agreement"). More specifically, I (on behalf of myself and the Minor), consent and agree that:

1. **Revocable License.** The Company is allowing me the privilege to use the shooting range pursuant to a revocable license that may be terminated by the Company at any time and for any reason.

2. **Physical and Mental Condition and Guardian Status.** I acknowledge that, at the time of signing this Agreement, I (and the Minor) am in sufficient physical and mental condition to engage in sport shooting on this range. If a Minor is named above, I am the legal guardian of the Minor.

3. **Inherent Danger of Activity and Assumption of All Risks.** I acknowledge the following:

- There are serious risks and danger to myself and others that always exist when engaging in firearms shooting.
- No matter what precautions I may take, including but not limited to the wearing of various types of protective gear (including hearing and eye protection), I can still suffer serious bodily injury and even die as a result of an accident or incident.
- I voluntarily and knowingly assume any and all responsibilities and liabilities related to or arising out of such risks, whether to myself or to others and without limitation or qualification.
- No express or implied representations of any kind have been made to me by the Company.

4. **Condition of Equipment.** I have, prior to engaging in any sport shooting at the shooting range, determined that my shooting equipment and all related items are in good condition and suitable for the shooting contemplated by this Agreement.

5. **Comprehensive Release.** I do hereby, on behalf of myself and the Minor, and our heirs, executors, administrators, assigns, and legal and personal representatives, unconditionally and irrevocably release and discharge the Company, the Company's successors, assigns, owners, shareholders, directors, officers, employees, agents, representatives, attorneys, independent contractors, subsidiaries, and affiliates and each, every and all persons acting by, through, under or in concert with any of them (collectively the "Released Parties") from and against any and all present or future claims, losses, liability, causes of action, demands or charges of every kind and nature, known or unknown, suspected or unsuspected, fixed or contingent, which I or the Minor may claim to have or to hold for the injuries or damages listed in a, b and c below, arising from any cause or reason, of every kind and nature pertaining to this Agreement and any activity directly or indirectly arising from or contemplated by this Agreement including without limitation my or the Minor's sport shooting on or about the Company's premises and/or facilities:

- a. Personal Injury (including, without limitation, wrongful death)
- b. Damage to property
- c. Any other injury or damage

6. **Indemnity.** I hereby indemnify, without qualification or limitation, the Released Parties and agree to defend and hold harmless the released Parties from and against any and all present or future claims, losses, liability, causes of action, demands or charges of every kind and nature (as well as reasonable attorneys' fees, litigation-related costs, and court costs incurred in defending any of the foregoing or in enforcing this indemnification), known or unknown, suspected or unsuspected, fixed or contingent, which any third party or person may claim to have or to hold for property damage or personal injuries or any other damages including death, arising from any cause or reason, of every kind and nature pertaining to this Agreement originating from my or the Minor's use of the shooting range and any activity directly or indirectly arising from or contemplated by this Agreement.

7. **Governing Law.** This Agreement shall be governed by, and construed in accordance with the laws of the State of Virginia. The terms, conditions and provisions of this Agreement shall be effective to the fullest extent permitted under Virginia law. The unenforceability or invalidity of any provision of this Agreement will not render any other term, condition or provision of this Agreement unenforceable or invalid.

8. **Additional Regulations.** I agree to follow all issued or posted rules or regulations issued or posted by the Company. I also understand that hearing protection and eye protection (even while using a scope) are mandatory at all Company shooting areas for all persons at all times. I agree that I will not fire or discharge any firearm or gun except in areas so designated by the Company. All ammunition used at the range must be purchased or obtained from the Company.
